**O&O:** Langseth updated the Board the Crailsheim project is set to have construction start in 2025. Bella Park the restrooms have been updated.

**KLR:** Their reported that KLR had their audit, everything looked good. They approved the budget for 2025, no levy increase.

**County:** Metz updated the board that the deadline for disaster reporting has been extended. County is double checking the bridges and piers for damage. Drainage ditch 9 & 13 have major damages.

#### **Old Business:**

**Soil Health:** We received the funds for the mentors. Jared signed a contract to be one of the mentors. Jess Dekam will also be a mentor for soil health

## **New Business:**

**Emerald Ash Borer:** The staff discussed the increase in local issues with the damages caused by the EAB. We have decided to update our cost share policy to adapt it to put in one row of trees to replace damaged ash trees. The policy will lay out the new perimeters for cost share. The row will have to be a hard wood tree and a larger size in order to be covered.
